- The group discussed model policies and the need for a designated authority figure/educator to be involved from the beginning, Amber suggested Dorothy Chaney, (school board policy committee)

- d. **Action:** Laura and Theresa will work on a packet of model policies, assessments, and key players to send out to the committee for them to look over and review

- 6) Cooking Carts Demo Lincoln Elementary







- a. Theresa will be demonstrating the cooking carts to 30 staff members at Lincoln School
- b. She will be demo-ing the cart and going over the Patriots' Day lesson found online under the School Wellness resources on the SDOM page
- c. The committee gave suggestions on her handouts for Lincoln Elementary School staff
- d. Deb also updated the group on her use of the cooking carts in Washington Elementary; K-6 grade students made food islands as part of the George Award. Was a great success!

7) Washington SRTS Updates

- a. Josh and Laura updated the committee on Washington SRTS
- b. Josh and Laura finalized the draft map based on the meeting with the PTO, got 15/16 different suggestions for improving the safe routes to school
- c. Next steps: LZ will package it up and send it back to PTO
- d. Laura, Josh, and Washington PTO are focusing on "lower-hanging fruit"
 - i. Looking at Wells Nature View and Christ Lutheran Church as specific drop sites, kids can get more PA from walking
- e. The group further identified partners to invite them to the meetings: Ron Sturomski, Director of Buildings and Grounds at School District of Marshfield, City Engineer, Police Chief
- f. Ron Sturomksi will be adding sidewalks in the summer
- g. Once Washington initiatives are established, the plan it to approach other schools and apply a similar process
